Given the recent growth of the organization we have enlisted professional help for our website and

online functionality which is a one-time increase to our administration costs.

3. TEAM is 100% volunteer- run and has no paid staff. Administration costs include insurance and general operational fees (e.g. bank fees, website maintenance, postage, etc.)

4. 2017 was a major year of growth TEAM, as we developed our individual giving program and hosted our first Party with a Purpose. As our revenue streams have grown, in 2017/18 we shifted our focus to intentionally pulling medical cases from shelters, at a much higher cost to our rescue. TEAM's medical expenses between 2018 & 2019 reflect this shift in priorities.
